Item 2 Educational Background and Business Experience

Nicklaus M. Areddy, CFP®, CRPC®

Nicklaus joined Diversified, LLC in 2026 as a Financial Advisor. Prior to joining Diversified, LLC, Nicklaus was a Portfolio Manager/Investment Advisor for Pollock Investment Advisors LLC since 2013. Nicklaus, born in 1991, is a 2013 graduate of University of Michigan, where he earned a Bachelor of Arts degree in Economics and Communications.

In 2017, Nicklaus earned the Certified Financial Planner™ designation (CFP®) from the College for Financial Planning. The CFP® is conferred by the Certified Financial Planner Board of Standards, Inc. after candidates have met all of the requirements for certification. Those requirements include having completed a Board-Registered educational program, having at least three years of qualifying work experience in the personal financial planning area, and passing the CFP® Certification Examination. The exam, which is administered over two days, tests a financial planner's ability to apply his or her knowledge to specific client situations. Individuals who become certified must complete 30 hours of continuing education hours every two years, including two hours on the Code of Ethics and other parts of the Standards of Professional Conduct to maintain the right to continue to use the CFP® marks.

In 2014, Nicklaus earned the Chartered Retirement Planning CounselorSM designation (CRPC®) from the College for Financial Planning. The CRPC® is awarded by the College after candidates have satisfied all requirements for certification. These requirements include completing a specialized, retirement-focused educational program and passing a comprehensive final multiple-choice examination designed to assess an advisor's ability to apply retirement planning knowledge to real client situations. Individuals who obtain the CRPC® designation are granted the right to use the CRPC® marks for a two-year period. To maintain this designation, CRPC® professionals must complete 16 hours of continuing education every two years and pay a renewal fee in order to retain the right to continue using the CRPC® marks.

Item 3 Disciplinary Information

Registered investment advisors are required to disclose all material facts regarding any legal or disciplinary events that would be material to your evaluation of each supervised person providing investment advice. There are no applicable disclosures to report for Nicklaus M. Areddy.

Item 4 Other Business Activities

While serving as a Financial Advisor for Diversified, LLC, Nicklaus is not actively engaged in any other business or occupation (investment-related or otherwise) and does not receive any commissions, bonuses or other compensation based on the sale of securities or other investment products.

Item 5 Additional Compensation

As noted in Item 4 above, Nicklaus does not receive any additional compensation beyond that received as a Financial Advisor of Diversified, LLC.

He maintains required books and records to monitor the investment advice and recommendations made on behalf of the firm.

Diversified, LLC has a specific Code of Ethics that applies to all employees. Mr. Levy implements procedures to ensure employees comply with the firm's Code of Ethics, and he monitors all reports provided pursuant to the Code.
